**RESOLUTION FIXING TAX LEVEY IN DICKSON COUNTY, TENNESSEE FOR THE YEAR BEGINNING JULY 1, 2018.**

This Resolution is to fix the Tax Levy Rate in Dickson County, Tennessee beginning **July 1, 2018**. The combined property tax rate for Dickson County, Tennessee for the year beginning **July 1, 2018** shall be Two Dollars, Seventy Cents (\$2.70) on each One Hundred Dollars (\$100.00) of taxable property. The following levies:
