This Resolution is to authorize the Purchasing Agent to enter into a contract with Clarksville Disposal for a dumpster to be delivered and serviced at the Dickson County Justice Center. Contract is for a period of Sixty (**60**) months at a monthly cost of One Hundred Forty Seven Dollars and Twenty Nine Cents (\$147.29). One time delivery charge of One Hundred Dollars (\$100.00).
