RESOLUTION FIXING TAX LEVY IN DICKSON COUNTY, TENNESSEE FOR THE YEAR BEGINNING JULY 1, 2015

This Resolution sets the combined property tax rate for Dickson County, Tennessee, beginning **July 1, 2015** at Two Dollars Ninety Cents (**\$2.90**) on each One Hundred Dollars (**\$100.00**) of taxable property, providing funds to General Fund, One Dollar Twenty Six Cents (**\$1.26**), Highway/Public Works, Eleven Cents (**\$.11**), General Purpose School, Eighty Eighty Cents (**\$.88**), and Debt Service, Sixty Five Cents (**\$.65**). Motion by Commissioner Linda Hayes, second by Commissioner Buford Reed to approve the Tax Levy for Dickson County, Tennessee for the year beginning **July 1, 2015** passed by a unanimous aye voice vote.
