Mr. Ben Eberly of TW Frierson Contractor, Inc. spoke to the Commission about the construction of the County Justice Center.

Mr. Eberly explained the areas of the construction relating to the total cost of the project. Mr. Eberly also told the Commission the process used in reviewing local contractors for their employment. TW Frierson received informational statistics from the contractors and by using this information made important decisions as to whether the contractor was qualified to work the project. Seven local contractors were selected to participate.

TW Frierson Contractor, Inc. stressed their transparency with the Commission during the construction process. Mr. Eby stressed to Mr. Eberly that the Commission wanted them to use as many local contractors as possible.

Mayor Bob Rial stated that he was not in agreement with the price of \$25,000,000.00. He stated that they worked to find a manageable cost and move forward. He also stressed to the Commission that building and maintaining the new Justice Center would NOT require a tax increase.

Motion by Commissioner Buford Reed, second by Commissioner Jeff Eby to discuss and/or approve the funding for the Justice Center.
