04-2021-01 RESOLUTION TO AUTHORIZE COUNTY TO ENTER INTO SETTLEMENT AND RELEASE AGREEMENT WITH TRISTAR HORIZON MEDICAL CENTER AS TO AMOUNTS OWED TO THE COUNTY FOR CERTAIN MEDICAL TRANSPORTS.

This Resolution is to authorize the county to enter into a settlement and release agreement with Tristar Horizon Medical Center as to amounts owed to the county for certain medical transports. Sum agreed upon to be paid by the hospital to the county for amounts that remain due and owing for transport services provided during the prior service period is One Hundred Ninety Thousand Dollars (\$190,000.00). The county is not contracting with HMC at this time. 04-2021-02 RESOLUTION TO AUTHORIZE EXECUTION OF SIXTY (60) MONTH LEASE WITH PITNEY BOWES FOR POSTAGE METERS AND RELATED SERVICES AND SUPPLIES.

This Resolution is to authorize the execution of a Sixty (**60**) month lease with Pitney Bowes for postage meters and related services and supplies for the following Court Offices: General Sessions Court Clerk; Clerk & Master, Circuit Court Clerk, and those located in the Administration Building.
