This resolution is to authorize the county to purchase a TEk84 Intercept Whole Body Security Scanning System together with related equipment, services and warranties from TeK84 Inc. for a total cost of One Hundred Seventy Nine Thousand Dollars (\$179,000.00) to be used by the Dickson County Sheriff's Office. Purchase funds will come from funds received under the American Rescue Plan Act. The county desires to expand the scope of services provided by T.W. This Resolution is to authorize the county to purchase a Pumper/Tanker Truck and to amend the County's General Fund (Fund 101) to appropriate funds to the budget established for the Dickson County EMA. Purchase consists of a 2021 Freightliner M2-106 Crew Cab Southeast Extreme Duty Pumper/Tanker, including a 1500gpm Hale Pump, 2000 Gallon water tank and related other equipment for a total cost of Three Hundred Seventy Five Thousand Dollars (\$375,000.00). DCEMA has requested an amendment to its current year budget from the County's General Fund (Fund 101) to the budget established for the County EMA for the purchase of the Fire Truck. Motion by Commissioner Clayton Ellis, second by Commissioner Johnnie Reed to authorize the County to purchase a Pumper/Tanker Truck and to amend the County's General Fund (Fund 101) to appropriate funds to the budget established for the Dickson County EMA passed by a unanimous aye voice vote.
